2. a poster presentation:

The posters will be presented in a relaxed atmosphere on April 9, 2019.

SUBMISSION OF ABSTRACTS

If you want to present a contribution your submission must include:

- Title of the paper and/or poster
- An abstract summarizing your paper
- Information about the lecturer and co-authors: name, title(s), company address, department, affiliation, e-mail, telephone and fax number

- In which topic area(s) your presentation should be listed

- How you would like to present your paper upon acceptance (full or poster presentation)

All abstracts will be reviewed. Please note that abstracts and final papers will be only accepted if they are uploaded to the conference's website:

www.partec.info

All submissions must be either Microsoft WORD (DOC or DOCX) or Portable Document Format (PDF) files. Your abstract must be received by April 30, 2018. Based on the abstract, the programme committee will decide on the acceptance and order of presentation in the conference programme. Please note that the number of co-authors named in the printed programme is limited up to two.

SUBMISSION OF THE FINAL MANUSCRIPT

If your paper is accepted you will be invited to submit the final manuscript, which must be received by January 11, 2019 the latest.

If you receive notification of acceptance, you will also receive instructions concerning manuscripts and a question form to be returned to the VDI Wissensforum. The accepted papers (full papers and posters) will be published in the conference proceeding USB-Stick provided to the conference participants.

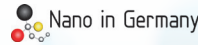

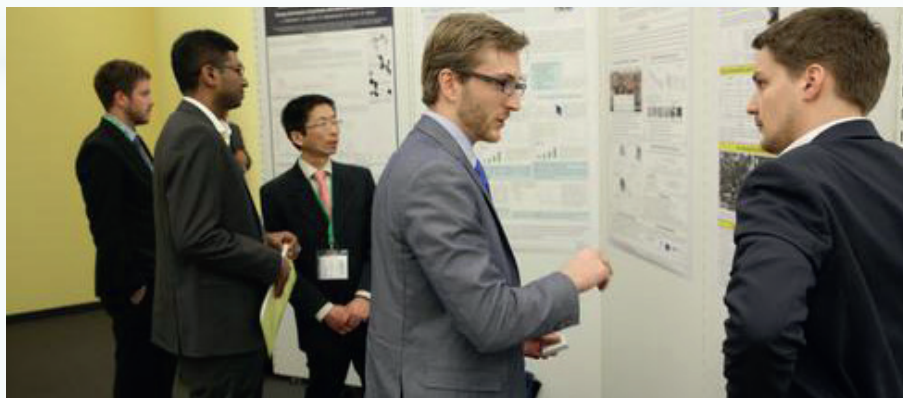
